1. LEAF ADOPTS NEW SUPREME COURT OF CANADA CASE (BARNEY v. CANADA)

LEAF will apply to intervene before the Supreme Court in Barney v. Canada (et al) this month. LEAF will be working in partnership on this case with the Native Women's Association of Canada (NWAC) and the Disabled Women's Network (DAWN) Canada.

Barney is a case that deals with some of the most appalling human rights violations that have ever incurred in Canada. The plaintiff in the case is Frederick Barney, an Aboriginal man who experienced repeated violent sexual assaults contemporaneously with emotional and physical abuse, isolation, and hunger as a child at the Alberni Indian Residential School during the 1960's. This was not an uncommon experience for Aboriginal children forced to attend residential schools. The residential school experience resulted in physical, psychological, spiritual and cultural harm for the most of the survivors of the experience, their families, and their communities. Barney is the first case of its kind and the outcome of this case will affect decisions made in future cases brought by survivors of institutional abuse.

The plaintiff in this case is a man who experienced the subject abuse as a child. Women and children are targeted for sexual violence and abuse because of socio-political conditions and power imbalances that create an experience of vulnerability that is imposed upon them. While boys, especially boys from disadvantaged backgrounds, are sometimes the victims of childhood sexual assault and abuse (as in this case), it is predominantly girls and women who are the targets of sexual abuse. It should also be made clear that the overwhelming majority of perpetrators of child sexual abuse are male. This reality will be central to the gender specific analysis that the LEAF coalition will apply in this case.

The LEAF coalition will make arguments in this case about the gendered racial affect of the residential school on Aboriginal women. For example, the high rates of violence within Aboriginal families can be linked to colonization and its practices, including the residential school system. In a recent study, approximately 25% of Aboriginal women reported being assaulted by a partner, compared to 8% for non-Aboriginal women in Canada. The residential school experience continues to affect Aboriginal women in Canada today as caregivers, parents and family members in Canada.

LEAF will be arguing that survivors of the Aboriginal residential school experience are entitled to compensation for physical and emotional abuse inflicted by the defendant prior to and contemporaneously with the sexual assaults at issue, as well as compensation for forced loss of culture and language. The oral hearing in this case is scheduled to be heard by the Supreme Court of Canada on May 16, 2005.

LEAF is a member of the Women's Future Fund (WFF), the first and only national women's federation in Canada. The goal of the WFF is to increase the self-sufficiency of national women's organizations that are working for equality and a better quality of life for women and girls across Canada.
