LEAF began as a grass roots effort...a conversation across the country and a collective response. Our founding mothers fought the Supreme Court's **formal approach to equality** of the 1970s, which had led the Court to uphold laws that discriminated against pregnant women and Aboriginal women among others.

Strong, organized and effective, they tasked themselves with ensuring that the *Canadian Charter of Rights and Freedoms* fulfilled its commitment to **substantive equality**, which recognizes historically and socially based **differences** and challenges systemic and structural **discrimination**.

Today, LEAF is an ever-evolving national charitable organization dedicated to litigation, law reform and education. Since 1985 we've made significant gains for women in over 150 important cases, advancing women's rights in the areas of reproductive freedoms, pay equity, employment, housing, immigration, family law and sexual assault law. LEAF has fought for access to justice and political, social and economic inclusion for women marginalized on the basis of sexual orientation, disability, race, Aboriginal identity, immigrant or refugee status and poverty.

True to our roots, LEAF continues to engage in a powerful dialogue about the inequalities we see in our daily lives and the importance of law and legal advocacy as a force for social change.

If You Think Our Work Is Done, Think Again.

Our Mandate in Action

Over the past two years, LEAF intervened in 11 cases before the Supreme Court of Canada and provincial appellate courts. Throughout this period, our Legal Director and pro-bono team of lawyers and experts brought the lived realities of women and girls in Canada into the Court, with particular attention to women's experiences of multiple inequalities on the basis of age, Aboriginal identity, poverty, disability, race, sexual orientation and other grounds, in appeals involving:

- » Violence against women
- » Socio-economic rights
- » Workplace inequality
- » Family law
- » Sex discrimination under the Indian Act
- » Human rights protections against hate speech
- » Access to justice
- » Constitutional equality jurisprudence

LEAF's advocacy has advanced the constitutional equality rights of all Canadians. And our work isn't finished yet. In fact, 2012 continues to be active with law reform efforts and landmark cases in which LEAF will intervene to shape substantive equality under the *Charter* and influence the perceptions and actions of all Canadians, so as to create a society in which all are respected and included.

2012 Interventions To Date:

» Addressed gender inequalities in spousal relationships and argued for the right of unmarried cohabitants to inclusion in family law property-sharing regimes

2010-2012 Interventions:

- » Argued that the prohibitive cost of litigating systemic constitutional equality claims reinforces the subordination of marginalized groups, undermines the rule of law and subverts justice in a constitutional democracy
- » Exposed the gendered effects of facially neutral federal legislation that gradually reduces death benefits for surviving spouses of public servants and military members, based on the age of the deceased
- » Supported the rights of sexual assault complainants with intellectual disabilities to access to justice and to be heard in Court

LEAF's longevity and demonstrated successes are due to the tremendous support we receive from our sponsors and donors, the legal profession, corporate partners, a dedicated staff and a team of volunteers who care deeply about equality.

- » Argued that consent to sex by a woman must always be active, voluntary, ongoing and revocable at all times
- » Contended that challenges to ameliorative programs by members of disadvantaged groups who claim they have been discriminatorily excluded should be subject to full s.15(1) Charter scrutiny of the alleged discriminatory effects
- » Maintained that the termination of spousal support for a disabled mother ignored the economic consequences of women's long-term caregiving roles and labour market inequalities
- » Challenged the interpretation of infanticide in the Criminal Code
- » Argued that a niqab-wearing sexual assault complainant should not be forced to remove her niqab to testify against men accused of sexual abuse
- » Emphasized that hate speech is a practice of discrimination

2010-2011 Law Reform

- » Challenged Bill C-3 (Federal), arguing that the proposed legislation did not fully and finally eliminate all forms of sex discrimination under the Indian Act
- » Opposed Bill 94 (Quebec), which legislates a norm or a "general practice" of "uncovered faces" as a precondition to accessing services and employment and which will uniquely discriminate against women who wear the niqab
- » Supported Bill C-389 (Federal) and called on the government to protect women from hate speech

Education

LEAF's equality training programs continue to transform high school students across the country. LEAF's No Means No program remains a leading violence prevention tool to educate and empower both young women and men by teaching them about sexual rights, responsibilities and the meaning of consent in law, so that they are less likely to become victims - or perpetrators. LEAF also recently completed its launch of a new program, LEAF at Work, an engaging dynamic workshop aimed at analyzing real-life scenarios to prepare youth for the gendered and other equality issues they may encounter in the workplace. The success of LEAF's educational programs is due to the hard work and excellence of LEAF branch and education program committee volunteers who train the instructors and deliver the workshops.

LEAF is also committed to enhancing our online resources and maximizing the public education opportunities in all of our legal work and communications.

EqualityRightsCentral.com (ERC), Launched September 2010

ERC is an innovative online resource that promotes dialogue; facilitates networking and sharing of information among equality advocates; and monitors and advances the development of equality law in Canada.

ERC provides updates through news articles, case summaries and comments, *facta*, and legislative updates related to equality, in *Charter* and statutory human rights cases – with a national scope. A broad range of topics are presented – from criminal law matters, to marital property law, immigration and refugee law, poverty, and LGBTQ rights.

THE CHARTER

LEAF is the only national organization in Canada that exists to advance the constitutional equality rights of women and girls through litigation, law reform and public legal education.

15. Every individual is equal before and under the law and has the right to the equal protection and equal benefit of the law without discrimination and, in particular, without discrimination based on race, national or ethnic origin, colour, religion, sex, age or mental or physical disability.

28. Notwithstanding anything in this Charter, the rights and freedoms referred to in it are guaranteed equally to male and female persons.

Milestones:

HISTORIC... SIGNIFICANT... PIONEERING... LIFE-CHANGING

Each year, LEAF celebrates landmark events that impact all Canadians. These important milestones underscore the continuing need for education, research and litigation that address all forms of discrimination.

Equality Day, April 17, 2011

LEAF honoured 8 women in non-traditional female occupations. These women have demonstrated that labour-market equality means not only equal pay for work of equal value but also equal access to male-dominated (and often higher paid and more secure) professions.

Women's Rights to Effective Representation in Parliament, June 2-3, 2011

LEAF and Equal Voice joined forces to strategize legal responses to the persistent underrepresentation of women at the highest levels of Canadian government.

Keynote speakers included The Rt. Hon. Kim Campbell, The Hon. Anne McLellan and The Hon. Frances Lankin.

Persons Day Breakfast, Toronto, October 18, 2011

LEAF National celebrated Persons Day in Toronto with its annual fundraising gala, marking the 82nd anniversary of the Supreme Court decision, which ruled that women are "persons" under the law.

Dr. Avis Glaze, international leader in the field of education, was the keynote speaker; the conversation was shaped by host, entertainer and social activist Heather Bishop. The event is LEAF National's largest annual fundraiser, attracting nearly 1,000 attendees.






